- 2.3 Appendix A to this report details how this ratio of members is shown in the allocation of members to committees/panels, depending on the total number of members on each committee/panel and in accordance with the proportionality rules and principles contained in the Local Government and Housing Act 1989. Appointments made to the Licensing Committee do not have to be on the basis of political balance but by convention this method is used to allocate seats.
- 2.4 Appendix B sets out the current range of committees with their total membership.
