LICENSING (ACTIVITIES) SUB-COMMITTEE

LICENSING ACT 2003 TEMPORARY EVENT NOTICE – BARTON TOWN FOOTBALL CLUB, MARSH LANE, BARTON UPON HUMBER

1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 To request that Members of this Sub-Committee determine a Temporary Event Notice (TEN) for Barton Town Football Club, Marsh Lane, received on 1 March 2016.
- 1.2 A summary of the TEN is attached as Appendix A and a copy of the TEN as Appendix B.

2. BACKGROUND INFORMATION

- 2.1 In accordance with the provisions of the Licensing Act 2003 and the council's scheme of delegation, all Temporary Event Notices where a relevant representation has been made need to be determined by this Sub-Committee.
- 2.2 When determining the TEN Members of the Sub-Committee should only consider issues, which relate to the Prevention of Crime and Disorder and Prevention of Public Nuisance objectives.
- 2.3 Members of the Sub-Committee must have regard to the statutory guidance issued under section 182 of the Licensing Act 2003 and our Statement of Licensing Policy. Members of the Sub-Committee may deviate from the statutory guidance and licensing policy only if they deem that there is good reason to do so.
- 2.4 Members of the Sub-Committee should not allow themselves to predetermine the Temporary Event Notice or to be prejudiced in favour or opposed to the Notice and shall only determine the TEN having had an opportunity to consider all relevant facts. Members of the Sub-Committee should not hear or decide on Temporary Event Notices in their own ward.
- 2.5 Members of the Sub-Committee must remember that they are acting in a quasi-judicial role in determining the TEN and shall remain in the room so that they hear all the evidence before determining the TEN. The determination shall be based on the evidence provided, which is relevant to the Prevention of Crime and Disorder and Prevention of Public Nuisance objectives.

- 2.6 The options available to the Sub-Committee having considered all the relevant information are as follows:
 - To issue a Counter Notice.
 - Not to issue a Counter Notice.
 - Impose relevant conditions (only where the event has an existing premises licence)

3. ISSUES FOR CONSIDERATION

- 3.1 The Temporary Event Notice was received on 1 March 2016.
- 3.2 A copy of the Temporary Event Notice is attached as Appendix B to this report.
- 3.3 There has been one notice of objection, from Environmental Health (Commercial), which has been deemed relevant. The objection is attached as Appendix C to this report.

4. OUTCOMES OF CONSULTATION

4.1 The Police and Environmental Health (Commercial) are served with a copy of the Temporary Event Notice. Environmental Health has made a relevant representation which is the subject of this report.

5. LICENSING OBJECTIVES & STATUTORY PROVISIONS

- 5.1 Prevention of Public Nuisance
 - 5.1.1 Environmental Health have raised concerns with regard to this objective, which is attached to this report at Appendix C.
- 5.2 Prevention of Crime and Disorder
 - 5.2.1 No concerns have been raised with regard to this objective.

6. FURTHER INFORMATION & CLARIFICATION

6.1 A site plan is attached as Appendix D and a copy of the existing Premises Licence is shown as Appendix E.

7. **RECOMMENDATIONS**

- 7.1 That the Sub-Committee determines the Temporary Event Notice in accordance with the Statutory Guidance issued under s182 of the Licensing Act 2003, our Statement of Licensing Policy, the information contained within this report and having had due regard to the applicant and those making representation.

- 7.3 That the Sub-Committee provides the reasons for its decision.

- 2. Every supply of alcohol under this premises licence must be made or authorised by a person who holds a personal licence.

General Conditions

The Club shall abide by the Club Rules as attached at Annex 2.

Prevention of Crime and Disorder

No conditions attached.

Public Safety

General Safety

The premises and all fixtures, fittings, equipment (including electrical fittings and equipment), furnishings, decorations and curtains on or about the premises shall be constructed, arranged safely, maintained in a safe and clean condition and in good working order (including where appropriate, good working order).

Electrical Safety

Emergency lighting shall be in place.

In the interest of public safety, all licensed premises shall be maintained to an acceptable level, In accordance with current legislation and safety standards, Premises licence holders and the DPS shall ensure that standards are maintained.

Temporary electrical installation shall be installed by a competent persons and be intrinsically safe and shall not remain connected to the permanent electrical supply when not in use.

Gas Safety

In the interest of public safety, all licensed premises shall be maintained to an acceptable level, in accordance with current legislation and safety standards. Premises licence holders and the DPS shall ensure that standards are maintained.

Fire Safety

In the interest of public safety, all licensed premises should be maintained to an acceptable level, in accordance with current legislation and safety standards. Premises licence holders and the DPS shall ensure that standards are maintained.

We recommend that everyone working in the premises (whether for payment or not) shall be instructed on what they shall do if there is a fire on the premises.

The Prevention of Public Nuisance

Licensees shall ensure that music or other activity at the premises does not control a nuisance or annoyance to nearby residents. They shall control any form of amplification to prevent such a nuisance. Noise shall not be audible from the boundary of the premises so as to cause a nuisance.

To help prevent noise nuisance, external windows and doors shall be kept closed during any entertainment consisting of music or singing.

Ventilation shall be provided at all premises. Where mechanical ventilation is used, it shall be maintained in a satisfactory condition.

External fire doors shall be fitted with self-closing devices. These must be kept in good working order and not restricted or disconnected.
