1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 To advise the Committee of all licenses, registrations, permits and consents issued by the Licensing Authority between 1 April 2010 and 31 March 2011, which fall within the Licensing Committee's terms of reference.

- 2.3 The comparison from 2008 to 2011 shows an increase in licenses issued of 8%. Much of this increase is from non-fee paying applications, which means that there has not been the same increase in income over the same period.
