## LICENSING PROCEDURE AT MEETINGS

## 1. OBJECT AND KEY POINTS IN THIS REPORT

1.1 To approve a procedure to be used at meetings of the Licensing (Miscellaneous) Sub Committee when considering appeals submitted by Hackney Carriage and Private Hire drivers against the imposition of penalty points by the council on the individuals licence.

#### 2. BACKGROUND INFORMATION

- 2.1 The Licensing Committee, at its meeting on 18 September 2014, formally approved the revised Hackney Carriage and Private Hire Licensing Policy. Amongst the changes approved, was the introduction of a penalty points scheme for drivers. The aim of the scheme was to introduce a cost effective method of dealing with drivers, proprietors and operators who have committed an offence or breached their licence conditions.
- 2.2 Depending on the seriousness of the offence or breach, drivers are normally given a warning.
- 2.3 However, where the Licensing Authority has deemed than an offence requires the imposition of points on the drivers licence, the scheme allows a driver, proprietor or operator to appeal the imposition of penalty points where they consider that the Officer was wrong to impose them.
- 2.4 Upon the receipt of an appeal, the Licensing (Miscellaneous) Sub-Committee will be convened to hear the appeal.
- 2.5 However, no procedure is currently in place that would allow the subcommittee to consider an appeal.
- 2.6 This procedure is attached as appendix 1

## 3. OPTIONS FOR CONSIDERATION

- 3.1 Option 1 To adopt a procedure to allow the Licensing (Miscellaneous) Sub Committee to hear appeals against the imposition of penalty points.
- 3.2 Option 2 To not adopt a procedure.

## 4. ANALYSIS OF OPTIONS

- 4.1 Option 1 The adoption of a procedure would result in the Licensing (Miscellaneous) Sub Committee having a structure in place to listen to the views of the appellant and Licensing Authority, before reaching a decision.
- 4.2 Option 2 Failure to adopt a procedure may result in the appellant not receiving a fair hearing or the laws of natural justice not being applied.

- 8. Questions by the Appellant and/or representative.
- 9. Questions from the members of the sub-committee.
- 10. Summing up by both parties and the Appellant having the right to the last word.
- 11. Both parties withdraw from hearing whilst members of the subcommittee consider the matter.
- 12. Both parties recalled and the sub-committee's decision(s) conveyed.
