- 1757 **TO APPOINT A LICENSING (MISCELLANEOUS) SUB-COMMITTEE COMPRISING FIVE MEMBERS OF THE LICENSING COMMITTEE (THREE CONSERVATIVE AND TWO LABOUR MEMBERS) COUNCILLORS K VICKERS (CHAIRMAN), P VICKERS (VICE-CHAIRMAN), CLARK, ELLERBY AND RAYNER - Resolved** – That a Licensing (Miscellaneous) Sub-Committee be appointed comprising five members of the Licensing Committee (three Conservative and two Labour members) Councillors K Vickers (Chairman), P Vickers (Vice-Chair), Clark, Ellerby and Rayner.

- 1758 **TO APPOINT A LICENSING (ACTIVITIES) SUB-COMMITTEE COMPRISING THREE MEMBERS (POLITICALLY BALANCED) DRAWN FROM THE 10 MEMBERS OF THE LICENSING COMMITTEE. (MEMBERSHIP OF THE SUB-COMMITTEE TO DEAL WITH INDIVIDUAL CASES TO BE APPOINTED AS REQUIRED FROM ELIGIBLE MEMBERS) - Resolved** – That a Licensing (Activities) Sub-Committee comprising three members (politically balanced) drawn from the 10 members of the Licensing Committee be appointed (Membership of the sub-committee to deal with individual cases to be appointed as required from eligible members).

- 1759 **LICENSING ACT 2003 - REVIEW OF LICENSING POLICY** - The Director: Operations submitted a report informing the Committee that the Licensing Policy must be reviewed in accordance with Section 5 of the Licensing Act 2003 by January 2022, and seeking approval to start the consultation.

The Licensing Policy was initially approved by the Committee in 2004 and then reviewed at regular intervals.

In accordance with Section 5 of the Licensing Act 2003 (the Act), there was a requirement for the policy to be reviewed every five years. The policy must be agreed by Full Council in January 2022.

The Act stipulated that in reviewing the policy, the council must consult with the police, fire and rescue service, licence holders, persons representing licence holders and other businesses or persons deemed suitable.

A copy of the current Licensing Policy was appended to the report.

**Resolved** – (a) That the Licensing Policy be reviewed in accordance with statutory requirements, and (b) that the start of the consultation process be approved.

- 1760 **GAMBLING ACT 2005 - REVIEW OF THE STATEMENT OF PRINCIPLES -**  
The Director: Operations submitted a report informing the Committee that the Statement of Principles must be reviewed in accordance with Section 349 of the Gambling Act 2005 by January 2022, and seeking approval to start the consultation process.

The Statement of Principles was initially approved by the Committee in 2006 and then reviewed every three years thereafter.

In accordance with Section 349 of the Gambling Act 2005 (the Act), there was a requirement for the Statement of Principles to be reviewed every three years. The revised statement must be agreed by Full Council prior to January 2022.

The Act stipulated that in reviewing the policy, the council must consult the police, fire and rescue service, licence holders, persons representing licence holders and other businesses or person deemed suitable. Further the Gambling Act 2005 (Licensing Authority Policy Statement) (England and Wales) Regulation 2006 specified a number of matters that must be contained in the Statement, including the description of the area and a list of consultees.

A copy of the current Statement of Principles was appended to the report. Subject to any responses to the consultation, it was not proposed to make significant changes to the document, if any.

**Resolved** – (a) That the Statement of Principles be reviewed in accordance with statutory requirements, and (b) that the start of the consultation process be approved.

- 1761 **APPEALS SUBMITTED TO THE MAGISTRATES COURT (IF ANY) -** The Director: Governance and Partnerships confirmed that there had been one appeal submitted to the Magistrates Court and this appeal had been dismissed, therefore the decision of the committee was upheld.

Two further appeals against officer decisions were pending to the Court and would be listed in July and August, a further updates on which would be provided in due course..
