LOCAL GOVERNMENT AND HOUSING ACT 1989 ('the Act') – POLITICAL BALANCE OF THE COUNCIL

1. OBJECT AND KEY POINTS IN THIS REPORT

1.1 The Council is required under the above Act to review the political composition of the council following its local elections held on 4 May 2023. This report initiates that review setting out a proposed allocation of seats available to appointed political groups/members on the size of committees/panels to be considered and appointed by Council.

2. BACKGROUND INFORMATION

- 2.1 The Council's political composition following the 4 May 2023 North Lincolnshire Council local elections is 27 Conservative and 16 Labour (43 elected members). In accordance with the Act, it is necessary that the Council now reviews the allocation of seats on its appointed ordinary committees for the 2023/23 council year to ensure that they are 'politically balanced'.
- 2.2 Appendix A to this report details how this ratio of members is shown in the allocation of members to committees/panels, depending on the total number of members on each committee/panel and in accordance with the proportionality rules and principles contained in the Local Government and Housing Act 1989
- 2.3 Appendix B sets out the current range of committees 2022/23 (pre-election) for information with their total membership.
- 2.4 Section 15 of the Act provides that any review must be carried out by applying the following four Principles, in priority order, as follows:
 - (a) that not all the seats maybe allocated to members of the same political group;
 - (b) where a majority of the members of Council are members of the same political group, a majority of the seats on each committee must be allocated to that political group;

- (c) subject to (a) and (b) above, the relationship between the total number of committee seats allocated to each group and the total number of seats on all committees must, as near as possible, be the same as the relationship between the number of members of the group as a proportion of the total number of members of Council; and
- (d) subject to (a) (c) above, taking each committee separately, the number of seats allocated to a particular political group reflects that group's proportion of the membership of the Council.
- 2.3 In carrying out its review, the Council may only depart from applying the principles by passing a resolution with no member voting against such resolution.

3. OPTIONS FOR CONSIDERATION

3.1 The Council is under a legal obligation to carry out a review of the seats allocated on its committees pursuant to the Act.
