Foreword by the Chair

Welcome to our Standing Advisory Council on Religious Education (SACRE) annual report for the period January – December 2021.

During 2021 SACRE continued to support schools across North Lincolnshire and beyond, as schools engaged with a new Agreed Syllabus. 2021 saw SACRE take a new direction and adopt the Lincolnshire Agreed Syllabus. In order to support schools in North Lincolnshire a series of training sessions were offered to all primary and secondary local authority schools and academies. The offer of training was extended to North-East Lincolnshire and the sessions were very well attended.

North Lincolnshire SACRE continued to support schools throughout the pandemic. Whilst there had been plans for the Annual Conference to return, these were sadly put on hold until 2022. It was a pleasure to see our SACRE meetings resuming face to face, this gave us the opportunity to fully discuss our support for schools during 2021.

Providing religious education is a statutory requirement and I believe that giving our children a broad knowledge of our diverse world is more important now than ever. I would encourage all schools to find space in the academic year to teach this important subject.

North Lincolnshire SACRE is robust in its commitment to schools and looks forward to increasing its membership in 2022.

Introduction: About SACRE

Councils have a duty to set up a Standing Advisory Council for Religious Education (SACRE). The duties of the SACRE include gaining an overview of the quality of religious education provision in local authority maintained schools and developing effective strategies to promote the highest standards.

The Agreed Syllabus Conference (ASC) holds the legal responsibility for revising the Agreed Syllabus. The ASC members are all members of SACRE.

Part of a SACRE's role is to support the effective provision of collective worship in community schools and to advise the local authority on issues related to provision and quality. It must also consider applications from head teachers in community schools that the requirement for collective worship to be wholly or mainly of broadly Christian character be disapplied for some or all of the pupils in that school.

SACRE 'determines' the appropriateness of that application and grants a 'determination' to those schools where the application is judged to be in the best interest of the pupils. All pupils in schools with determination continue to have an entitlement to daily collective worship.

A SACRE is set up to represent a balance of all the interests of the local community. This includes elected councillors, representatives of local faith communities and members of the education community. The constitution of the SACRE is determined by law.

SACRE Membership and Minutes of Meetings SACRE Membership is comprised from:

- Representatives of Christian denominations other than the Church of England and representative of other faiths
- Representatives of the local Church of England dioceses
- Representatives of Teachers' Associations
- Local Authority Representatives

During 2021 North Lincolnshire SACRE held two meetings which took place on 17th January and 28th September 2021. At these meetings, the Strategic Officer for SACRE presented the Annual Report (for the period January to December 2020) and also the NASAC report on funding. The Strategic Officer shared advice passed on to schools around RE and Collective Worship during lockdown.

In addition, the Strategic Officer presented the NASACRE virtual training plan 2021-22 and also advised that the next annual conference would be held on 11 March 2022.

Self-Evaluation

Within the self-evaluation process the focus was on supporting schools to teach high quality RE. It was agreed by all members to adopt the Lincolnshire Agreed Syllabus from September 2021 and that SACRE would fully fund the purchase of the Agreed Syllabus and cover all costs of training. Moving forward the self-evaluation would focus on the impact of the new syllabus and ways to continue to support schools. The SEF reflected the need to support schools to teach high quality RE during the pandemic, whether that was virtually or within the constraints of schools re-opening

Additionally, when undertaking self-evaluation, it was agreed by all members who have attended SACRE meetings that membership is low and a focus for the SEF was on the reasons why meetings were, on occasion, not quorate and ways forward to encourage greater membership to ensure representation from local faith groups and members of the education community which are representative of North Lincolnshire.

The LA officer attended NASACRE training on the Self-assessment Toolkit and this will form the basis of the self-evaluation process moving forward.







Collective Worship

The quality and monitoring of RE provision in schools

- Religious Education provision is monitored within faith schools via school governors and by curriculum and diocesan leads, and also by Ofsted via Section 48 inspections.
- Collective worship provision is monitored via LA school reviews and Ofsted inspections.
- Secondary GCSE results are monitored by SACRE.

Advice to statutory bodies

Local Authority

Any enquiries from members of the public, parents or schools are responded to via the Lead Officer for SACRE. This may relate to Freedom of Information, research questions and the discrimination of any statutory guidance and or updates.

Agreed Syllabus

In 2021 SACRE agreed to adopt the Lincolnshire Agreed Syllabus with effect from September 2021. SACRE purchased the syllabus for all Academies in North Lincolnshire and Local Authority schools.

SACRE funded a series of training sessions for all North Lincolnshire Schools and Academies in order to support the implementation of the new Agreed Syllabus. These were led by Gillian Georgiou the Lincolnshire Diocesan RE Adviser, who was instrumental in writing the Agreed Syllabus. Sessions focused on both subject knowledge development and leadership in RE. In order to support colleagues beyond North Lincolnshire the training was opened to North-East Lincolnshire and was well attended by both primary and secondary colleagues from NE Lincolnshire.

These online sessions focused were recorded and sent to all schools.

 Where SACRE noted academies were not following the AS the chair wrote to schools to confirm what RE was being taught and to remind them of their statutory responsibility to teach RE. The LA representative contacted SIPs who followed up concerns in schools.

SACRE has noted there is still work to do to support the teaching of RE in secondary schools, particularly academies this will be the focus of a working party in 2022-23.

However this does not educate pupils about any likely risks in their own community. Leaders acknowledge they must develop this further to ensure pupils know how to stay safe when they are not in school.
Barton St Peter's	Primary	9-9 December 2021	The curriculum, in subjects such as reading, mathematics, science and religious education, is well planned and sequenced. Each year, learning builds on what pupils have been taught before. As a result, pupils are remembering more.

Due to the impact of the Covid-19 pandemic school inspections did not resume again until January 2021. Research visits to schools by Ofsted are taking place and whilst these are technically inspections, no reports are being published but letters are being sent to schools following visits.

Due to the impact of the Covid-19 pandemic, no SIAMS Section 48 inspections were carried out in North Lincolnshire between January and December 2021.

Management of SACRE and contribution to the wider local authority agenda

- The officer with responsibility for SACRE provides information for the Council, which in turn provides support and encouragement for the work undertaken. The Council is also clerked so that whatever it undertakes is ably administered.
- LA Officer is fully funded to work for SACRE
- North Lincolnshire Council provides funding to support the development of the SEF
- North Lincolnshire SACRE continues to be financed as a statutory function of North Lincolnshire Council.
- SACRE provides information, advice and guidance to support Religious Education for all schools and early years settings. This includes working in partnership with local communities and faith groups to support a shared understanding of each other's beliefs, faiths and values.
- The Agreed Syllabus provides a framework for our work, support and partnership working and includes a range of support for head teachers, governors and RE coordinators.

- SACRE works closely with different Faith and Community Partnerships to develop a shared understanding of different communities Having a shared approach to celebrating national events such as Faith Week, Children's Day and contributing to celebrating a shared sense of place in how we live our lives together within North Lincolnshire.
- SACRE usually hosts an annual conference to provide a forum to share best practice, innovation in terms of teaching and learning resources and a place to consider and reflect on key themes relating to faith and beliefs. The conference was unable to be held during 2021 due to the restrictions of the Covid-19 pandemic.
- SACRE provides regular support for trainee and early career teachers, it provides opportunities for RE Leads to come together to share planning, ideas and resources to enhance teaching and learning across all phases of education.

Links to broader community initiatives

- Members of SACRE represent a range of faith interests and groups from within the North Lincolnshire communities. The Board has an elected member as the chair and the work of the group is supported, on behalf of the Board, by council corporate services.
- Members of SACRE aim to bring a representative view to the board meetings and oversee the statutory functions of SACRE.



Holocaust Memorial Day 2021



This year's theme, 'Be the light in the darkness' is very timely and will resonate with lots of people across North Lincolnshire living through the pandemic.



Standards and quality of provision of RE – GCSE examination results (as at 2019)






The proportion of young people achieving a Grade 4 or above (grade A*-C prior to 2018) in Religious Studies has seen a slight decline between 2014 to 2019. Nationally, figures remained stable at 72%.

In North Lincolnshire there has been a drop of 0.4 percentage points between 2014-19, compared to a 0.8 percentage point rise seen nationally.

Religious Studies GCSE outcomes: A*-G / Grade 9-1



The proportion of young people in North Lincolnshire achieving a pass (grade A*-G/9-1) in Religious Studies has declined slightly since 2014.

This decline is not mirrored nationally, where there has been a slight increase of 0.7 percentage points since 2014.



Religious Studies - A Level outcomes:



Religious Studies - A Level outcomes:



In 2020/21, 41.7% of young people achieved Grade A*-A in Religious Studies in North Lincolnshire. This was an increase of 6.4 percentage points from the previous year.

The outcome for North Lincolnshire was 1.9 percentage points below the National average of 43.6%.

In 2020/21, 87.5% of young people achieved Grade A*-C in Religious Studies in North Lincolnshire. This was an increase of 5.1 percentage points from the previous year.


The outcome for North Lincolnshire was 3.8 percentage points below the National average of 91.3%.

In 2020/21, 100% of young people achieved Grade A*-E in Religious Studies in North Lincolnshire. This was equal to the previous year.

The outcome for North Lincolnshire was 0.3 percentage points above the National average of 99.7%.

- In both 2019/20 and 2020/21 attainment shows increases compared to 2018/19, higher than would be expected in a typical year. This likely reflects the changes to the way A Level grades were awarded rather than improvements in student performance.

Annual SACRE Conference


Whilst the 2021 Annual Conference was unable to go ahead, we are currently planning the 2022 Conference to take place on 11th March 2022.
