	1.2	The key points in this report are:
		A compliant competitive procurement exercise was undertaken by Crown Commercial Services (CCS) with a Call Off competition under their Technology Products and Associated Services Commercial Agreement (RM6068) Lot 2 Hardware & Associated Services. An aggregated eAuction was completed under Lot 2 which North LincoInshire Council submitted requirements for Lots 2. 3. 7. 1(b) & 8 (a)
		The award criteria used was most economically advantageous tender with a ratio of 70% price and 30% quality applied.
		The award stage consists of a Qualification, Technical and Commercial evaluation.
		The contract commencement date is 1 December 2021. The duration of the contract will be 24 months, with an option to extend subject to satisfactory performance and budget allocation for a further 24 months.
		To seek Director of Governance and Partnerships approval to award the contract to the preferred bidders.

2. BACKGROUND INFORMATION

2.1 The Authority were contracted under the previous aggregation arrangement, EA16 awarded under the RM1054 Crown Commercial Services framework agreement for 2 years plus 1, plus 1 year from 1/6/2016 until 31/5/2020, this was subsequently extended due to Covid under PPN01/20 until 31/5/2021 to enable the arrangement of EA21. A subsequent further delay in the procurement resulted in an extension until October 2021 which was agreed by Exception.

- 2.2 A representative from North Lincolnshire Council ICT Services participated in the development of a specification (statement of requirements) and procurement arrangement for an aggregated procurement along with 27 other Local Authorities known as the EA21 Board. A statement of requirements was agreed on 8th July 2021.
- 2.3 The authority submitted forecast requirements for Lots 1(b), Lot 8(a), Lot 2, Lot 3 and Lot 7.
- 2.3 An aggregated further competition was run by CCS on behalf of the authority and 27 other contract authorities, under the CCS Technology Products and Associated Services (RM6068) Framework, Lot 2: Hardware & Associated Services known as NFC126 EA21 Hardware Aggregation.

3. OPTIONS FOR CONSIDERATION

3.1 **Option One – To award the contract to the preferred providers**

- 3.1.1 These contracts would meet the needs of North Lincolnshire Council and ICT services.
- 3.1.2 This option meets the requirement of being the most economically advantageous bid.

3.2 **Option Two – Not to award the contract to the preferred providers**

3.2.1 This option would put the council in breach of The Public Contract Regulations 2015 as an Exception to the CPRs to extend the already expired contract would be required as there is no time to conduct a new procurement.

4. ANALYSIS OF OPTIONS

- 4.1 Stage 1 Quality evaluation Technical Bids was completed on 11 to 18 August 2021 with CCS acting as the 'Agent' in undertaking a procurement event for the Contracting Authorities to source Suppliers to fulfil the requirement.
- 4.2 In total, 37 Potential Bidders were invited to participate in this procurement event. In total, 31 Potential Bidders did not submit a bid of which the consensus was this was due to inability to provide the required items. 6 providers submitted a bid as follows:

- 4.3 1 tenderer was unsuccessful and was eliminated from the process at this stage.
- 4.4 The CCS Aggregation Lead, on behalf of the Contracting Authorities, signed a report to agree to the invitations to eAuction being issued.

4.5 **Stage One – Technical Bids**

4.5.1 The technical scores were weighted in order to determine rank when entering into the next stage, the eAuction. There were 5 tenderers who successfully completed Stage One and progressed to Stage Two to participate in the pricing element.

4.6 Stage Two – eAuction – Price

4.6.1 The eAuction element was held on 25 August 2021 and conducted by the CCS eAuction team. It was extended to the 26 August and subsequently 27 August 2021. The following suppliers were invited to progress to Stage 2 eAuction element of the procurement.

4.6.2 The Bidder whose total bid is the lowest at the end of eAuction, for each Lot and is ranked 1st, i.e. the lowest ranking Bidder at the end of the eAuction was to be awarded the Call Off Contracts (subject to due diligence). The award of the resultant contract will be on the basis of the 'Most Economically Advantageous Tender' (MEAT).

5. **RESOURCE IMPLICATIONS (FINANCIAL, STAFFING, PROPERTY, IT)**

5.1 **Financial**

- 5.1.1 The combined cost of these new services is £673,037 over 2 years.
- 5.1.2 This figure may reduce depending on the number of devices purchased over 2 years.

5.2 Set up and Monitoring

- 5.2.1 No additional resources will be required for set-up of the contract.
- 5.2.2 Quarterly account manager meetings to take place to ensure that the device remain fit for purpose as technology changes and that stock is available within agreed timescales.

6. OUTCOMES OF INTEGRATED IMPACT ASSESSMENT

6.1 Integrated Impact Assessment carried out and no negative impacts identified.

7. OUTCOMES OF CONSULTATION AND CONFLICTS OF INTERESTS DECLARED

7.1 To ensure that the skills, background and experience of the evaluation team were appropriate for this procurement, each evaluator completed an evaluator declaration form. CCS found no conflicts of interest were declared.
